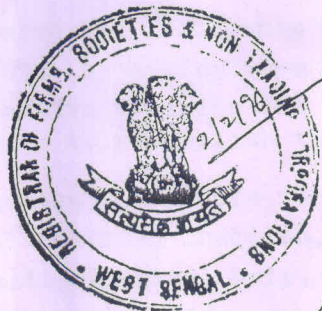

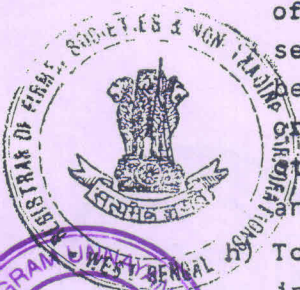

3. The SGUS will for the present oprate in Bhagwanpur, Block - 1.
But the area operation may be extended as and when necessary.

: AIMS AND OBJECTIVES :

4. The Aims and objects of the SGUS are :
 - a) To assist the development of economic, social and cultural life of the people residing within the area of its operation on community, family and individual basis.
 - b) To initiate and guide the materialisation of the resource potential of the area of operation by adoption of scientific methods and modern technologies in the fields of irrigation land development, agriculture, horticulture, grassland farming animal husbandery, pisciculture, village and small industry etc.
 - c) To assist in development of the infrastructure of the area of operation by establishing or strengthening model farms, training centers, credit, storage, supply and marketing, facilites, repair workshops etc. to accelerate the achievmnt of objects (a) & (b) .
 - d) To train, guide and assist the people of the area of operation in democratic organisation, democratic functioning and social action on the one hand and adoption of modern technologies and scientific methods on the other for the achivement of objects (a & (b) .
 - e) To develop the leadership potential of the people and specially the youth, by making them responsible for specific group tasks, by intensive training and by imparting to them the necessary experties to accomplish them satisfactorily.
 - f) To organise the people for and guide and help them in eradication of poverty, inaction, hunger, inqyities, social evils on the basis of mutual help, collective endeavour and co-operative enterprise.
 - g) To act generally ~~the people for and guide and help them in eradication of poverty, inaction, hunger, inqyities, social evils on the basis of mutual help, collective endeavour and co-operative enterprise.~~ as link between government agencies on the one hand and the people of the area of operation and their organisation on the other in order to secure for the latter a due share in the facilities already being offered, like various material inputs, customs service, credit facilities, training facilities grants, subsidies and other financial assistance and to ensure distributive fairness and justice, specially for the weaker sections of the community.
- To co-operate and collaborate with national and interational institutions and agencies working with the same or similar objects; and to help and receive assistance from other similar institutions groups or individuals for mutual benefit.

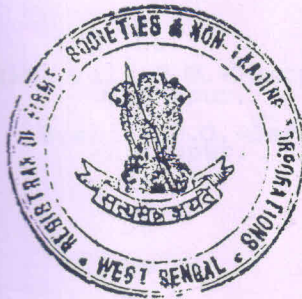

- v) To do such other acts as are incidental or conducive to the attainment of any or all of the above mentioned aims and objects.



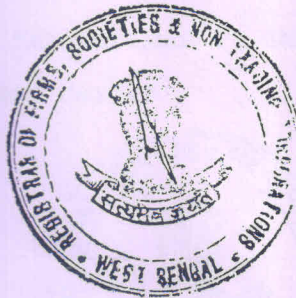

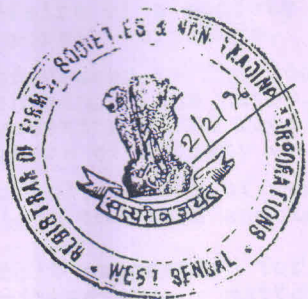

THE WEST BENGAL SOCIETIES REGISTRATION ACT, 1961.

REGULATIONS OF ASSOCIATION

OF SOCIETY.

MEMBERSHIP

1. Qualification and admission :-The following persons are eligible for membership of the Society :
- Any person who has attained the age of 18 years and who agrees in writing to be bound by the Memorandum and Regulations of the society.
 - Any society or institution, whose objects are similar to those of society will be represented by the secretary or any incorporated company or limited company to be represented by one of its directors.
2. Class of members :
- Patrons,
 - Life members,
 - Ordinary members,
 - Honorary members.
- The Managing Committee may invite any distinguished person to become a patron of the Society.
 - Live Members :- Any persons Institution, Society or Incorporated company, qualified to be member, by paying or having paid a sum of Rs.500/-on doing movable or immovable property of the value of Rs.500/-or over shall be elected a life member of the society by the Governing Body.
 - Ordinary Members :-Any person, Institutions, society or incorporated company, qualified to be member, paying ordinary member of the society and month-subscription at Rs. 0.25/-.
 - Honary members :- Any person, qualified to be member, whose connection with the society is deemed to be necessary by the Founder members may with the consent of such person be electe an Honorary member of the Governing Body nor shall be entitled to vote at any meeting.
3. Cessation of membership :- Any member shall cease to be a member
- On his resignation from membership by a letter address to the secretary,
 - On his becoming insane or involent,
 - On his conviction any offence in connection with formation, promotion, or conduct affairs of a society or a body corporate or any offence involving moral turpitude.
4. Register of Member :- The society shall maintain a Register of members containing the names, address and their occupation, the date of cessation,. The register will be kept open for inspection of the members of society on requisition.
5. Rights and obligations of members:-
- Any member of the society has the right to elect and to be elected in any election of the society.
 - To submit suggestion for discussion to the Governing Body and subcommittee on any matter.
 - To inspect the accounts of the society on appointment with the secretary.
 - To forgo his membership after due information in writing to the Governing Body.
 - To pay his subscription within the prescribed time.
 - Dafaulting members shall not be allowed to take part or vote in meeting.
 - Members shall have one vote each.



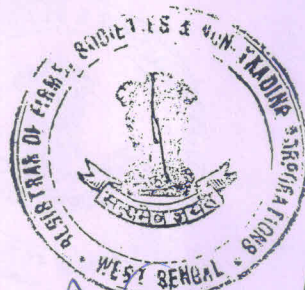

GOVERNING BODY.

- Composition and election :- There shall be a Governing Body consisting not less than five and not more than 20 members and will be composed of the Founder members and elected members. Elected members shall be elected at the annual general meeting of the society. The Office bearers of the Governing Body shall consist of President, Vice-President, Secretary, Assistant Secretary and Treasurer. The office bearers shall be elected by the Governing Body from amongst themselves.
2. Termination of membership :- A member of the Governing Body shall cease to be a member of the Governing Body if (a) he resigns by letter addressed to the Secretary, (b) he absents himself from three consecutive meetings of the Governing Body without any leave or without any reasonable ground, (c) he is convicted of any offence in connection with the formation, promotion, management or conduct of the affairs of the society, or of a body corporate, or of any offence involving moral turpitude.
 3. Meeting :- A meeting of Governing Body shall be held at least once in three months at such place and time as the president or the secretary may determine. Any five members of the Governing body may requisition the meeting of the Governing Body and the Secretary shall summon the same within seven days and failing which the president or the requisitioner may do so provided on business other than specified in the notice shall be transacted at such meeting.
 4. Notice :- Seven days notice of the meeting specifying the place, time and the general nature of work and business to be transacted shall be given to every member of the Governing Body. Emergency meeting may be called on 24 hours notice. Four members personally present shall constitute a quorum for the meeting and if a quorum is not present within 30 minutes of the time the members present may adjourn the meeting.
 5. Procedures of the meeting :- The president or in his absence the Vice-President shall preside over all meeting of the Governing Body and in their absence members present shall elect a Chairman of the meeting. All questions before the meeting will be decided by a majority of votes each member having one vote. The president or the chairman shall have a second or casting vote in addition to his own vote in the case of equality of votes.
 6. Powers and Duties of the Governing Body : The Governing Body shall have general power of supervision and conduct over all the affairs of the society and in particular shall discharge the following duties :-
(i) To summon the Annual General Meeting of the Society (ii) To appoint sub-committee with such power and duties as may be considered necessary of expedient, (iii) To accept donation, gift, subscription moveable or immovable property for the objects of the Society, (iv) To sell, lease, mortgage or otherwise dispose of the deal with all or any part of the property of the society, (v) To keep proper accounts of the society to open bank account in the name of the society in one or more of the banks, Bank accounts will be operated by the President jointly with the Secretary or Treasurer of the Society.

:: SAFE CUSTODY OF FUNDS ::

1. The Governing Body or the trustee of the society shall be responsible for the safe custody of the funds and assets of the society.
2. The funds of the society shall be kept in the local Bank and be invested in any securities specified under section 20 of the Indian Trust Act -1882.

BOOKS OF ACCOUNS & INSPECTION OF

books of accounts and other statutory books shall be kept at the registered office and shall be open to inspection of the member of the Governing Body during usual office hours and the same shall be open to inspection of the members at such time and place as the Governing Body directs on a written request made by any members.

:: ACCOUNTING YEAR ::

The accounting year of the society shall be English Calendar year.

:: GENERAL MEETINGS ::

1. There shall be own kinds of general meetings.
a) annual and b) special or extraordinary.
2. The society shall hold an annual general meeting as last once in every year and not more than 15 months shall elapse between two successive annual general meetings. At least 14 days notice specifying the time; place, the day and hour shall be given to every member of the society.
3. The quorum for transaction of any business, shall be one third of the total members in the register present either personally or by proxy.
4. The business to be transacted at the annual general meeting shall be :-
(a) To confirm the minutes of the last annual general meeting and if any.
(b) To adopt with or without modification the report of the working of the society for the previous year ended.
(c) To pass audited accounts for the said year.
(d) To appoint qualified auditor or auditors.
(e) To elect president and other office bearers of the Governing Body.
5. A special general meeting shall be convened by the Secretary if two-thirds members of the society requisitioned such meeting specifying the nature of the business to be transacted at the meeting on receipt of such notice the secretary shall hold such meeting with 21 days. In default by the secretary, the requisitionists shall hold such meeting, provided no business other than that specified in the notice shall be transacted.

:: DUTIES OF OFFICE BEARERS ::

1. PRESIDENT :

- (a) He shall preside over all meetings of the society.
- (b) Take all disciplinary actions such as removal dismissal etc. in consultation with the Governing Body.

2. SECRETARY :

- (a) He shall convene all meetings of the society.
- (b) maintain minute books of all meetings.
- (c) issue general circulars and notice.
- (d) receive all applications for membership of the society which shall be placed before the Governing Body.
- (e) sign on behalf of the society all receipts for all sums received as subscription etc.
- (f) sign and give pay order on all bills for payment, and
- (g) transact all other business subject to the direction of the Governing Body.

3. TREASURER :

- (a) He shall collect and receive all sorts of subscriptions, donations and deposit of money and grant receipts there of.
- (b) maintain and keep cash book and such other accounts as are necessary.

SUITS & LEGAL PROCEEDINGS

All suits and legal proceedings by or against the society shall be in the name of the secretary or by such person as shall be appointed by the committee for the occasion.

ALTERATION OF RULES & REGULATIONS

The Governing Body shall have powers to make such Byelaws and Rules and regulation as may be considered necessary in the interest of the society. These Rules and Regulation may be altered, modified, rescinded or added to by special resolution passed by the members in general meeting valied by the purpose by three- fourths majority of the members president at such meeting.

DISSOLUTION OF THE SOCIETY

The society may be dissolved by a resolution to that effect passed by three- fourths of the members of the society present at a general meeting. The said meeting shall also decide the manner of disbursement of the funds and assets of the association, if any, after dissolution.

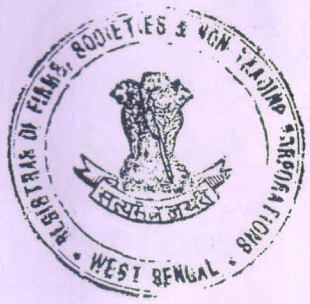
